### **SDP Priorities 2022 - 2023**

Every year we ask pupils, parents/carers, staff, governors and the wider community two important questions:

- 1. What is working well?
- 2. What do we need to do to make things even better?

The answers to these questions tell us what priorities we need to work on over the coming year.

Our SDP priorities are grouped under 5 headings; these headings come from Estyn's Common Inspection Framework (September 2022).

Summary of our key SDP priorities for 2022-2023 are outlined below. Full details of our will be found in the full SDP; this is available on the school website.

#### **Estyn recommendation** This was the only recommendation from our June 2019 inspection.

Develop further the school's strategies to meet the needs of pupils as it implements the Curriculum for Wales (CfW).



### Inspection area 1: learning



Ensure all pupils make progress in line with their individual needs and abilities; including full access to our wide range of accredited programmes (ASDAN, DofE, AQA, work experience etc.) for pupils in the 14-19 learning pathways classes.

## Inspection area 2: wellbeing and attitudes to learning



Whole school and departmental training (Thrive, ELSA, TIS, outdoor learning etc.) to support pupils' health and wellbeing.

Inspection area 3: teaching and learning experiences



Further develop strategies and resource to support full implementation of CfW.

Re-open specialist rooms (sensory, rebound, soft play etc.) when COVID allows.

### Inspection area 4: care, support and guidance



Embed MOVE programme in relevant classes; work towards Gold Award.

Upgrade calming rooms and remaining outdoor areas.

Full implementation of PIVATS 5 to track pupil progress.

### Inspection area 5: leadership and management



Enhance links with satellite classes.

Review current SLT to ensure it meets the demands of increasing numbers and complexity of pupils.

Work with LA officers to implement ALNET Act, including staff access to specialist training and support.
